Due to the fact the defendant admitted to 2900 Temple Hill Rd, being his residence, the fact that the plastic baggie with crystal like substance was located in the same place the defendant was first observed to be in the residence upon SWAT entry and that the substance field tested positive as methamphetamine, weighing approximately 20 grams (over the 14 grams for trafficking per Florida State Statute) probable cause exists for the defendant for Trafficking in Methamphetamine.

The defendant is a convicted felon and therefore per Florida State Statute is prohibited from possessing firearms or ammunition. The defendant was placed under arrest and transported to the lake county jail without incident.
