Before me, the undersigned authority personally appeared _____ who being duly sworn, alleges, on information and belief, that on the 03rd day of NOVEMBER, 2021, in LAKE County, Florida, the defendant did:

Commit the offense: Written threats to do violence. FSS 836.10(1)

On November 3, 2021 while working as the school resource deputy at Umatilla middle school I was advised by administration of a snap chat post circulating advising of a school shooting to take place at this school on this date.

I observed the post that read - "Am shooting up umitilla middle scholl today bc all yopu 6,7, and 8th graders are fake as fuck y'all bitches got me expelled for selling nic - - y'all bitches are going to pay on god"

Shortly after hearing of this news the assistant principal, Mrs. Fielder brought the juvenile offender, Thea Stiles to my office to question her about the post. Upon questioning offender Stiles by Mrs. Fielder, offender Stiles denied having a phone. At this time, Mrs. Fielder searched offenders belongings and discovered the phone. Offender Stiles then denied sending the snap chat post before she was even questioned about a post. Offender provided the pass code for the phone. Mrs. Fielder located the post saved to the phone.

Offender Stiles provided a written statement stating that she made and sent the post out this morning on the bus because she was upset.

Offender Stiles was taken into custody without incident.
